Dr. David Conn gave a presentation on the University Self-Study process that is currently underway. A self- study must be done every ten years to establish reaffirmation of accreditation by the Southern Association of Colleges and Schools.

There are two components of the study:

- 1. Institutional Effectiveness
- 2. Strategic Component Information Technology

Information will be assembled and the final report written and signed in December 1997. This report will be available on the Self-Study Homepage and the university community is asked for input as to the accuracy of the report. The "Team Visit" part of the process will take place March 15-18, 1998 at the Donaldson-Brown Center. The final decision on accreditation by SACS will be received by December 1998.

Two-thirds of the staff agree that Information Technology has improved ability to carry out their jobs.

Lack of Flexibility. Lack of funding for Incentive Pay Plan. 70% agree that staff efforts to improve performance through information technology should be given greater recognition in performance evaluation.
