Staff/Faculty Dependent & Spouse Scholarship fund: Devon Smith, Asst. Director for Annual Giving

- See presentation sent out by Robert Sebek
- 526 staff members participated in this year's Giving Day
- Cannot give tuition waivers as benefit to dependents or spouses so they started an endowment fund to do this

- As of 2018 this scholarship has awarded \$146,000
- To be eligible: must be full time student, have a parent or spouse working at VT, fill out a FAFSA form, mark on application that parent or spouse works at VT
- HR then verifies and the person will get a scholarship
- Everyone who applies will get something; amounts are based on the number of students and how much money is available that year
- Selection is made by a committee
- Can give by payroll deduction, recurring gift, one time gift, or planned giving (benefit from an estate or life insurance)
- Fill out the form, put in a sealed envelope and send it to Gift Accounting

# **Upcoming Campus Construction Projects:** Dwyn Taylor, Assistant Vice President for Capital Construction & Renovations

- see presentation sent out by Robert Sebek
- Capital Projects must be approved by the BOV, increase square footage by at least 5,000 sq. ft, or exceed \$3 million in total project costs
- About 4 year process to get projects approved and completed
- More projects in this next year than ever before; here is what is happening in the next 6 months 1
  year
  - Chiller Plant Phase II near cage lot; starting in Spring 2019; increase capacity and connect the 2 plants; impacts most of campus; open for bids 2 weeks ago and in the process of awarding the bid; should start in June 2019 and take 30 months to complete
  - 2) Creativity & Innovation District LLC 3 dorms at the old University Club locations; have 600 beds; 3 buildings will be connected; now under construction; 2 years to complete; should open in Fall 2021
  - 3) Holden Hall renovation & replacement; front part of the building will be renovated while the back will be demolished; going under construction in June 2019; open in the Fall 2021
  - 4) Student Wellness War Memorial Hall renovation and Schiffert Health Center renovation; start December 2019 is anticipated; 2 year time frame for completion; Schiffert may stay partly open if possible which may slow completion time
  - 5) Package Boiler #2 turn old coal boiler into steam or natural gas boiler; taking bids starting in April; increase capacity by January 2020
  - 6) Student Athlete Performance Center above the football practice field behind Cassell; design for bid going out in April; dining expansion for student athletes; starting construction in Summer 2019; will take 15 months to complete
  - 7) Undergrad Science Lab under design now but not funded fully yet; north of the New Classroom Building on Perry Street; finish design in December 2019; hoping state will fund next year; start construction in 2021 if funded
  - 8) Hitt Hall & New Dining Center connected to Bishop-Favrao Hall; 600 seat dining hall; construction to start in the Fall 2019; finished in the Fall 2021; donor/dining funded
  - 9) Merryman Center Weight Room renovation for student athletes
  - 10) Multi Modal Transfer Facility (MMTF) managed by the Town of Blacksburg; create 2 bus stations with shelters on loops for West Campus Drive and Stanger St; currently under design but over budget so correcting design to get back under budget; starting in Spring 2020
- Lots of these will reduce the amount of parking for everyone; can see more by looking at the 30 Year Master Plan for the University
- Robert is trying to get more information about the loss of parking spaces for these new projects
