### Governance 101: Ellen Plummer

- Authority-Governing Board
  - Virginia: Board of Visitors, Code of Virginia, and other state regulations (the university is a State Agency-two actually)
  - Board delegates "day to day" to the president
  - President delegates to selected senior administrators
- Representation
  - Over time (since the 1960's) has expanded to include varied constituencies
  - Two Concepts
    - Various groups share in key decision-making processes (often through elected representation)
    - Allowing groups to exercise primary responsibility for specific areas of decision making
- Decision-making is contextual
  - Resources, politics, mission(s), politics, personalities, politics, relationships, resources, influence, politics....repeat
  - Views of the world
    - **Students** (and everyone else)
    - **Faculty** (and everyone else)

- Administrators (and everyone else)
- **IT People** (and everyone else)
- Everyone Else (and everyone else)
- Trends-Pressures-Forces-Issues-Opportunities-whatever
  - Demographic Shifts
  - Budgetary constraints
  - Increased compliance requirements from government agencies/regulations
  - Public perception of the cost vs value
  - Increased demands from students for ease of access and availability of services
- More Context
  - Shared governance-commitment to democracy
  - The creation + discovery of knowledge-messy and inefficient!
  - Privilege and prestige are currencies of the realm
  - Academic Freedom protecting interrogation and discovery (no church or state inquisition)
    - Peer Review
    - Tenure
    - Teaching + Research
  - Independence
  - Multiple organizational cultures: disciplinary, academic, administrative, student, faculty, staff, stakeholders
  - Multiple organizational cultures: disciplinary, academic, administrative, student, faculty, staff, stakeholders
  - o Vocabulary, dress, office operations, expectations, rewards
- Governance at Virginia Tech
  - o Includes major constituent groups-internal and external to the university
  - Requires community to be informed, involved & knowledgeable
  - Best when there is communication
  - Council, Commissions, Senates (elected)
  - Caucuses, + other groups
- Shared Governance
  - Voice but not necessarily authority and Accountability
  - Benefits from abundant communication
  - Office of the VP for Governance and Policy (BOV, University Council + Commissions, University Policies
  - Curriculum: Office of the Registrar
